1. Meeting Summary

- a) NYSDEC presented the roles and responsibilities per the State's and the National Flood Insurance Program's (NFIP) floodplain management requirements.
 - a. Key contacts for DEC's Central and Western NY Flood Hub Floodplain Coordinators were shared.
 - b. A review of the NFIP was shared. The key goals and definitions were highlighted.
- b) Flood response and post-flood activities were shared, including documentation and permits.
- c) FEMA provided additional information on public assistance, post-disaster communications, and adoption/enforcement of floodplain ordinances.
- d) The following poll questions were gathered, and the results are included in the follow-up:
 - a. *What county are you representing?*
 - b. *What is your role in community flood management?*

Q&A – Action items highlighted in red.

Q: Paul Taft, Village of Bronxville - *Is this being recorded and available later?*

A: Brienna Wirley, DEC - **not recorded but slides can be provided as pdf.**

Q: Sheri Norton, Ontario County - *Can the Survey123 use the NYS Streets data for road name dropdown? This would help immensely providing standardized entry.*

A: **Thomas Song, FEMA - FEMA will investigate it and will provide an answer when we share the slides.**

Q: Ryan Murphy, Southampton Town - *Market value is the value with the damages sustained? Or pre-storm market value? Can you just hit that again?*

A: Brienna Wirley, DEC - Market value is based on pre-damage condition.

Q: Paul Taft, Village of Bronxville - *Cedar is using survey 123*

A: Thomas Song, FEMA - There are other geographic datasets that can be used with the Survey123 software. It's seamless. If you want to use a dataset that's not prepackaged in the program, then you can upload it but that will take some technical knowledge.

Q: CMW Fusco engineering - *As you said the flood plains for this previous storm have changed. But the documentation you were using as you said are for people in the flood plains. Would that be the previously documented or the area flooded period?*

A: Brienna Wirley, DEC - The substantial damage requirements that we are discussing apply to the current effective Special Flood Hazard Area as designated on the community's Flood Insurance Rate Map. All effective mapping is publicly available on FEMA's Map Service Center.

Comment: Thomas Song, FEMA - A community's flood damage prevention ordinance (FDPO) will normally regulate development in a Special Flood Hazard Area. Extreme rain has caused flooding in areas outside flood zones. It is a challenge for communities to get people to rebuild more flood resilient when the property is located outside flood zones.

Q: Dave Kvinge, Westchester County - *Do County governments have any kind of role to play here? I believe that they have resources they can bring and can assist in facilitating the sharing of resources among municipalities within their jurisdiction. They can also assist in other tasks like education and outreach and management of mapping and other data through economies of scale.*

A: Brienna Wirley, DEC - Unless the County has a role in floodplain management or building code enforcement there is no direct responsibility under the NFIP. What you mentioned is exactly how the county can assist local municipalities.

A: Thomas - if you are interested in discussing ideas on how Westchester can help local efforts now or in the future, we would be happy to meet.
