## FROM THE SUPERVISOR:

COVID-19 Surge.

COVID continues to spread throughout East Bloomfield, Ontario County and beyond. In

order to stay safe, we encourage everyone who is eligible to become vaccinated and boosted. Governor Hochul has issued a mask requirement for all public entities who do not require proof of vaccination. All municipal buildings would be included in this executive order. It remains in effect until January 15, 2022. All persons entering East Bloomfield Town Hall will be required to wear a mask while conducting business in the facility. Ontario County continues to offer drive through clinics for vaccinations, testing and mask distribution. We have posted this information on our Town website.

We are in the process of doing the final editing to the East Bloomfield Recreation Master Plan. Once completed, it will be available online, as well as a hard copy on file in the Town Clerk's Office. One of the top survey responses was a desire to have pathways for walking, running and cycling. Another popular survey response indicated a desire to offer more outdoor and indoor recreation opportunities for everyone, including Senior Citizens. We will be searching for grant opportunities to cover the expenditures for trail and pathway development. We are thankful to the committee that worked on the plan, who included people from the Village, Bloomfield Schools and the Community. The former plan was adopted in 2006. It was definitely time to update the plan.

As you know, East Bloomfield has a new pavilion in Veterans Park, located near the playground on the northern end of the park. The location is ideal next to the upper parking lot and close to activity areas.

Jaylene and Joel Steele spearheaded this project with several fundraising efforts. A Pavilion Committee met regularly to discuss and decide upon fundraising strategies. Representatives from Rotary and Lions actively participated, as well as employees of the Town. It was truly a community wide effort which exceeded its goal. The Pavilion Committee was also able to have other amenities donated to Veterans Park, such as the two permanent outdoor grilling stations and the ADA compliant picnic tables. The committee is currently working on having roof gutters added to the pavilion and also having an ADA compliant sustainable toilet facility installed near the pavilion (similar to the toilet facilities in Boughton Park). The goal is to continue to make our parks attractive and functional for everyone in our community.

#### **VETERANS PARK/ELTON PARK**

The Veterans Park - American Legion Building and new Pavilion are open for events. The American Legion Building has two rooms (Meeting Room and Community Room) available for reservation, or you can reserve the entire facility. The Pavilion is also available for reservation.

Elton Park is required to be reserved for large groups over 25 people.

Veterans Park (including its' buildings) and Elton Park are carry-in & carry-out facilities. Visitors take <u>all</u> trash with them when they leave, including any recyclables.

#### **BOUGHTON PARK**

To use Boughton Park, you are required to have a Boughton Park Vehicle Tag. Vehicle Tags for East Bloomfield residents are available at the East Bloomfield Town Clerk's Office. You must provide a valid NYS Driver's License and Vehicle Registration showing your East Bloomfield address.

#### RECYCLE MEDICATIONS

East Bloomfield Town Hall is an official drop-off site for old medications. A secure, locked box is located in the public meeting room at the Town Hall.

#### **RECYCLE EYEGLASSES**

Bloomfield Lions Club has 2 collection boxes for used eyeglasses. One is located at the Bloomfield Big M entry and the second is located at the Honeoye Branch of Canandaigua National Bank.

#### DOG LICENSES - annually

All dogs 4 months or older, harbored in the Town of East Bloomfield must be licensed. Proof of current Rabies Vaccination must be furnished. #### **BUILDING PERMITS**

As a reminder, please remember that the following items require a building permit: additions/remodels, decks, porches, roofs, pools, sheds and permanent pergolas. Projects that do not require permits: patios and sidewalks, garden boxes, dirt for uneven ground or holes and new driveways.
